

## Lawton Chiles Middle School Band 2025-2026 Instrument Rental/Usage Information

The Lawton Chiles Middle School Band and the school board of Seminole County are providing your child with an instrument to use during the 2025-2026 school year. You are responsible for the care and upkeep and repairs while it is in your possession.

Seminole County will take inventory during the school year. Prior to that day, all school-owned instruments must be brought back to school, and they will be returned to the student when inventory is complete. Students are responsible for taking care of this instrument while it is in their possession.

Tuba students will be assigned a tuba to play in class. This will be a class set. There will be one student each period assigned to that tuba, and each student will use their own mouthpiece. Additional tubas will be distributed to be taken (and left at) home. We cannot guarantee every student has a home tuba, as we only own a certain amount, but we will make every effort to offer additional options (such as weekend take home, before and after school practice times, etc.)

The instrument rental fee is \$75 per semester.

If you wish to pay in full by September 30th, please accept a \$25 discount.
